As I have mentioned previously, for several months a committee of staff, board members and our attorney, Steve Sherard, has reviewed the REA By-Laws to bring them up to date with current State Statutes and recommended best practices. We have finally completed the recommended changes. These changes will be presented at the REA's Annual Membership Meeting on March 15 at the 4H Building in Wheatland. We hope everyone can be there and we look forward to seeing you there! The Annual Membership Meeting is a unique event for electric utilities, as Electric Cooperatives are the only type of electric utility that hold such an event. This meeting is YOUR meeting; YOU are the member-owners of this utility! As you are the member-owners of Wheatland REA, Wheatland REA is a member-owner of Tri-State Generation and Transmission, which is also an electric cooperative. Tri-State has 43 members that are all member-owners and participate in the governance of the utility pretty much the same way Wheatland REA's nearly 2000 members participate in our governance, one member; one vote. The Co-op business model is unique in the electric utility industry, no other electric utility has a business model where the members are also the owners and have such a direct say in the governance. The Cooperative is here to serve the members, not the other way around. We, as Cooperative employees need to be attentive to the members' needs and listen to the members. While we have a business to run, we still need to listen to our members and see if we can come up with reasonable solutions to members' concerns. We need to remain aware that we are stewards of our members' money, and we need to ensure we are using these funds for the overall good of the Association. Electric Cooperatives were built on the concept of sharing for the overall good of all members, however, we need to maintain a balance of the good of the individual member, versus the good of the overall membership.

We have heard comments that perhaps Electric Cooperatives have outlived their purpose since much of America is no longer rural. I absolutely disagree with this thought and Wheatland Rural Electric Association is a perfect example of why these Cooperatives are still needed today. Wheatland REA averages about two meters per mile of line and when the cost of building line is \$30,000-\$40,000 per mile and that mile will only serve an average of two meters, you don't have to look too hard to see that very few for-profit companies would be interested in taking on such a liability. Our purpose is to provide affordable electricity and improve the quality of life for our Member-Owners. We continue to do our best to serve you, our member-owners. If you have any concerns or questions please give us a call and we will be happy to help. As this is your Cooperative, please plan on attending the Annual Membership Meeting on March 15 at the 4H Building As always, it is a pleasure to serve you!


