We also prepared for the eclipse event during this time.

As for the State Fair, by all reports, the Cooperative booth was a resounding success! The Wyoming Department of Agriculture awarded Wyoming Touchstone Energy Cooperatives and Tri State Generation and Transmission the Wyoming State Fair Sponsorship Honor Award! Part of the citation reads "... You have repeatedly chosen to support our State Fair and Fairgrounds knowing your customers have deep roots in the programs and experiences made here. Most recently, your commitment to the naming rights of the Show Center Building will serve to further the programs and facilities available year round for Wyoming Agriculture and for Wyoming Youth." This is a huge honor for Tri State and the Wyoming Touchstone Energy Cooperatives! Our emphasis is placed on the rural residents in the state and the recognition we received from these awards is greatly appreciated! To me, the fact the Department of Agriculture specifically mentions Wyoming youth struck a significant chord, as I have a true passion for these future leaders of our commu-

Unfortunately, these events are not all we have going on at the REA, there is the reality of politics. I received notice this morning that the EPA and the Army Corps of Engineers (Corps) will be holding meetings for recommendations on a new Waters of the U.S. (WOTUS) rule likely to be proposed in 2018. NRECA will present comments on behalf of electric cooperatives around the country. It is anticipated that the EPA and Corps will propose to withdraw the 2015 WOTUS rule that, as you may recall, was never implemented due to federal courts issuing a "stay" resulting from various legal challenges over the rule. I would encourage any of our members with an interest, to find out about these meetings and give your input to these rules.

As always, it is great to be here at Wheatland REA and to serve you! Please stop in and say hello! We are always happy to see you! Again, thanks to everyone who works so hard to make this a great state!

The hardest part of the budget is revenue. Will we have drought, lots of moisture, a hot summer, or an extremely cold winter for 2018? 
