With the last elections, Colorado governance swung heavily to the more renewable energy side of the equation, and they are looking to force aggressive moves to what they have determined as "cleaner" forms of energy. At this time, Tri-State's energy mix is over 30% renewable energy, and they are always looking at more cost-effective energy. However, that is apparently not good enough for some of our neighbors to the south. We will continue to monitor this situation and voice our concerns and support for Tri-State as appropriate.
