In our initial meeting, their CFO, Mr. Pat Bridges, presented their current financials, along with their budget and future forecast. When it was explained to me, it was very interesting and made total sense. Tri-State is dealing with a lot of happenings, i.e. contract issues, a committee to review opening current contracts, and new legislation in Colorado which will affect coal-fired power plants they currently own. Even in all the chaos and conflict, Tri-State continues to stay true to the cooperative principles. As a cooperative, we have to appreciate that they are keeping with the principles we all strive for.
