

On to the issues at Tri-State Generation and Transmission. As you recall from my previous articles, two Tri-State members are attempting to withdraw their memberships, and have contested the cost of buying out of their contracts. The two members have filed their cases with the Colorado Public Service Commission (CPUC). Tri-State has filed its methodology for determining the buyout cost with the Federal Energy Regulatory Commission (FERC). The cases at the CPUC and FERC are essentially competing cases, and the determination of the case can have a significant impact to the remaining members of Tri-State, including Wheatland REA. We are continuing to provide support and input where we are allowed. The CPUC has denied our motion to intervene, and even denied the Wyoming Attorney General's motion to intervene. The Colorado General Assembly has submitted a letter to the FERC encouraging the FERC to allow the CPUC to make the decision - a decision which, of course will not take into consideration the best interests of Wyoming and the members here. To counter the Colorado General Assembly letter, many Tri-State members have sent their own letters to the FERC. This is a battle, and we are doing our best to support you, the member-owners of Wheatland REA.

I was recently asked if we are involved in giving input to Tri-State, and working to keep energy prices lower. I will tell you that we are very involved at Tri-State! Jack Finnerty is your Board of Director's representative to the Tri-State Board of Directors, and Jack is well respected there and has a voice that is heard. As I mentioned above, we are providing input, and even leading some of the battles, to ensure your interests are considered. We stay involved everywhere we can to make sure we have input at all levels of Tri-State.


The fireworks stand will be open June 27th - July 3rd, from 10:00 a.m. to 9:00 p.m.
