

It is hard to believe that fall is almost here. A summer like no other, hot and dry! Our large power load is down, and irrigation load is up. It goes with the rest of 2020, a year of abnormalities and extremes. I personally hope these are not the new normal!

There has been quite a bit going on at the REA, even outside the pandemic stuff. We have had public safety issues, and worked at the state fair. We have folks working with businesses on new large loads at the Guernsey Tank Farm. We have had contractors in town doing our annual line re-clearing, as well as contractors testing and treating our wood poles. We have watched various wildfires spring up in our area. We also received the loan of a Tesla electric vehicle. I will highlight a few of these areas.



On the safety side of things, PLEASE DO NOT PUT ANYTHING into or near a power line or our equipment! This includes plastic pipe, boards, sticks, branches, ANYTHING! Some of the power lines in this area run at 345,000 volts. Our linemen's tools are specially designed, tested and treated to deal with the appropriate voltage, whereas a piece of PVC pipe is neither designed nor tested for working around voltages and can result in severe injury or death. If there is something in the line, just call us or 911, and we will get it taken care of! We think the world of you and don't want any of you to get hurt!

Also, along the lines of safety, there have been a few wildfires flare up in the area. I would like to compliment the firefighters and other first responders for getting on these fires quickly and getting them contained in short order! This year, 2020 events or not, with the extreme weather conditions we've experienced, it's not the year to let a fire get out of hand! Our first responders leave their families, jobs, and other responsibilities to make sure we are safe, and our resources are protected. Thanks for all you do!

In August, Wheatland REA, Tri-State G&T, and the other electric cooperatives in Wyoming, worked at the Wyoming State Fair. We were concerned that it would be cancelled at the last minute, considering all of the pandemic restrictions. However, Al Teel continued to press forward with the planning, in case it did happen, and it did! I have not seen the attendance numbers, but my perception is they were down a little, but not that bad considering everything. Those folks that were there seemed to be having a great time and enjoyed being out and interacting with others. I was thrilled to run into a few of you up there, and enjoyed the few minutes we had to talk!

Prior to the State Fair, Wheatland REA received the loan of a Tesla electric vehicle (EV) to test and get out in the community, and we had it on display at the fair. While EV's have been around for a few years in more urban areas, their exposure in more rural areas has been limited. I have driven it around a bit, and pushed the distance of the battery, and I think it performed well. I am not saying it will be a replacement for my <sup>3</sup>/<sub>4</sub> ton truck anytime soon, but as a pavement vehicle, it has been comfortable. With planning, charging has not been much of an issue. The idea of EV's being tested by an electric company is that they are just another electric load, and the more load we serve, the more our costs are shared. Like I said, this is a pavement vehicle, and while I will not admit to how fast I had it up to, let's just say it will easily reach highway speeds in a very short time!

Looking ahead, October is National Cooperative Month. Since you do not receive the WREN magazine with our articles until about mid-month, we want to let you know now that we are planning some celebrations in October. The allocations cannot be processed until the Board approves the audit of the 2019 financials. Just a friendly reminder, this is only a notice of what is being allocated to your account, and not the amount of the capital credit retirement check that you will receive in 2021. If you have any questions, please call the office.

Fall is the time we start planning our 2021 budget. It is truly a challenge because there are so many factors that play into our financial status every year. You know Mother Nature, don't you? Well, that is a big one, as is another factor that we all know, COVID19! It plays a factor in so many areas, including the day to day work.
